RESIDENCY REGISTRATION INFORMATION

In-Person

- Bring completed registration form, signed and dated. **Sign both sides.**
- You are required to show a driver's license or state I.D. and current utility bill (**both forms are required**) to verify eligibility to purchase a pass at the resident rate. **Other forms of I.D. are not accepted.**
- Payment-in-full** is required at time of purchase

Mail-In

- Return completed registration form, signed and dated. **Sign both sides.**
- Enclose copies of your driver's license or state I.D. and a current utility bill (**both forms are required**) to verify eligibility to purchase a pass at the resident rate. **Other forms of I.D. are not accepted.**

RULES & REGULATIONS

- The staff is authorized to charge and collect all applicable fees established in the fee structure.
- Season passes are valid for the period from March 15th, 2024 (weather permitting) through November 15th, 2024. All passes include playing privileges at no additional charge at Greenshire Golf Course.
- Season Passes **ARE NOT VALID FOR OUTINGS, OUTSIDE EVENTS OR TOURNAMENTS** held at the club. **FULL PAYMENT** is expected for **OUTINGS, OUTSIDE EVENTS OR TOURNAMENTS HELD BY THE CLUB. NO EXCEPTIONS.** (These include any scrambles, tournaments, Turkey Shoots.) INITIALS: _____
- Passholders must check in and present their PASS OR A VALID PICTURE ID each time you play.
- All players and guests at the golf courses are subject to the rules and regulations established by the Park District.
- To restore playing privileges, a \$100 processing fee must be paid along with any fees or charges associated with past unpaid play at the golf course.
- Anyone submitting false or misleading information about residency shall have their playing privileges revoked.
- **NO OUTSIDE FOOD, BEVERAGE OR ALCOHOLIC BEVERAGES ARE PERMITTED.** It breaks the facility's liquor license and is a control issue. Water bottles are allowed only. Anyone caught with these items will be asked to dispose of them immediately in front of said staff person. If any season passholder refuses staff will confiscate said items and dispose of them at the clubhouse. Upon confiscation, season passholder will face the penalty as follows 1ST Violation – 2 week suspension or 14 Days and \$100 processing fee ; 2nd Violation – 1 Month (30 Days) , 3rd Violation – Suspended For The Remainder of Season and the following season. Refunds for season passes will not be given to any person found in violation of this policy.

- To restore playing privileges, a \$100 processing fee must be paid along with any fees or charges associated with past unpaid play at the golf course.
- No refunds will be granted for any fees or charges incurred.
- **Season passes may not be used for or credited toward golf outings.** Normal tee times may be cancelled for Waukegan Park District events or golf outings. INITIALS: _____
- **Holiday Rates/Weekend Rates will be charged as follows for the 2024 golf season. include Memorial Day Monday, May 27, 2024; July 4th Independence Day Holiday Thursday, July 4 2024 and Friday, July 5 2024; Labor Day Monday, September 2, 2024.**
- Early closures may occur on holidays. Early closures on holidays may mean the golf course will close at 7:00PM or 7:30PM dependent on time of the season.

RESIDENCY REQUIREMENTS

- **Residents:** The **Waukegan Park District Resident** is a person whose home is within the boundaries of the park district. Residency is the permanent and principal address of the individual occupying the home, apartment, condominium or estate.
- **Rental Property:** Property owned by individuals but rented by others. The owner of this property may not be considered a park district resident even though he/she owns the property. This property is rented to others who may be classified as the Waukegan Park District residents because they have established permanent residency at the location.
- **Commercial Property:** Owners of commercial property who reside outside the park district are considered non-resident.
- **The resident must show their driver's license and current utility bill to verify eligibility to purchase a pass at the resident rate. Both forms are required. Other forms of I.D. are not accepted.**
- Anyone submitting false or misleading information about residency shall have their playing privileges revoked.

GOLFING WAIVER

WARNING OF RISK & IMPORTANT INFORMATION

Golfing is an activity that challenges and engages the physical, mental and emotional resources of each participant. However, despite careful and proper preparation, instruction, medical advice, conditioning and equipment, there is still a risk of serious injury. Understandably, not all hazards and dangers can be foreseen. Risks inherent to golfing include poor conditioning or technique; being struck by a golf ball or club; being struck by lightning; slipping on wet surfaces; slip and falls associated with the choice of spikes; accidents with golf cars; inconsiderate play; horseplay; defects in course design; and premises defects and hazards. In this regard, it must be recognized that it is impossible for the Waukegan Park District/GolfVisions to guarantee absolute safety.

You should always stand away from and behind a player making a shot and be aware of the flight patterns of balls being hit by other players when you are around the greens and alongside the fairways. You should watch where you are walking or driving golf car (i.e., uneven terrain, sprinkler heads, surface imperfections, etc.); when playing a shot from a wrong fairway, ensure that the players playing that fairway are aware of your presence. Drive carefully and slowly in golf cars, as they are not toys. During a thunderstorm, do not ride in golf cars or stay outdoors; seek shelter in buildings, vehicles, or other locations that offer protection (avoid open fields, water areas, wire fences, overhead wires, isolated trees, and hilltops). Play should also be discontinued during a tornado warning (siren is sounded); seek shelter in the basement of the clubhouse or, if caught outside, in a ditch or low area.

GOLF CAR USE/RENTAL AGREEMENT

(Applicable when golf cars are rented)

I represent that I am familiar with the operation of Waukegan Park District's golf cars and agree to return said car at the end of each play in the same good condition as received. I understand that golf car drivers must have a valid driver's license to be eligible for car rental. I agree to keep any car rented to me in my custody while in use and not to sub-lease or re-rent the same car. I further agree not to remove a rented golf car from Park District property. I understand that not more than two persons and two golf bags are to be in a car at any one time. I agree to abide by all rules and will assure passengers abide by rules as well.

WAIVER AND RELEASE OF ALL CLAIMS AND ASSUMPTION OF RISK

Please read this form carefully and be aware that in signing up and participating in this activity, you will be expressly assuming the risk and legal liability and waiving and releasing all claims for injuries, damages or loss which you or your minor child/ward might sustain as a result of participating in any and all activities connected with and associated with this activity (including the use of golf cars, when provided).

I recognize and acknowledge that there are certain risks of physical injury to participants in this activity, and I voluntarily agree to assume the full risk of any and all injuries, damages or loss, regardless of severity, that my minor child/ward or I may sustain as a result of said participation. I further agree to waive and relinquish all claims I or my minor child/ward may have (or accrue to me or my child/ward) as a result of participating in this activity against the Waukegan Park District/GolfVisions, including its officials, agents, volunteers and employees (hereinafter collectively referred as "District" or GolfVisions).

I do hereby fully release and forever discharge the Waukegan Park District/GolfVisions from any and all claims for injuries, damages, or loss that my minor child/ward or I may have or which may accrue to me or my minor child/ward and arising out of, connected with, or in any way associated with this activity.

In the event of an emergency, I authorize Bonnie Brook Staff to secure from any licensed hospital, physician and/or medical personnel any treatment deemed necessary for my minor child/ward and agree that I will be responsible for the payment of any and all medical services rendered.
